

502 Power Yoga Retreat Terms & Conditions

These terms are regarding the Tulum Yoga Retreat, Friday, February 14—Wednesday, February 19th, 2025.

Payments & Cancellation Policy

A non-refundable \$500 deposit and agreement to the terms and conditions listed below are required to guarantee your registration. Your booking is not considered definite and no contract will exist until we receive your deposit and you agree to the terms and conditions listed below. Your deposit is final and nonrefundable.

The remaining balance must be paid in full by December 14, 2024. The remaining balance must be paid with a credit or debit card on file with Walla, and the participant agrees to pay fully for the retreat according to the agreed-upon plan (see your plan on page 3). If any balance is left on your account, and no arrangements have been made for payment, then we reserve the right to cancel your booking.

In the event that you must cancel your retreat enrollment, we must receive your request in writing, and the following terms apply:

- Your deposit is nonrefundable
- If enrollment is canceled on or before December 14, 2024 (2 months before the start of the program) any payments made toward the balance, less a 10% cancellation fee, will be refunded.
- If enrollment is canceled on or after December 15, 2024, no refunds will be issued. However, if another person can be found to take your place, then we **may** offer you a refund, less a 10% rebooking fee, at our discretion.
- There are no refunds for an unused portion of the retreat.
- If the reason for cancellation is covered under the terms of your Insurance Policy, you may be able to file a claim with your insurance.

Any changes made to the Payment Plan once established by 502 Power Yoga must be provided in writing to Cat Crawford (cat@502poweryoga.com) at least 10 business days before the scheduled payment date and will be subject to a \$25 Change Fee, per change.

Retreat Description:

I have read and understand the description of the retreat and I understand what is included/excluded in the retreat cost. Specifically, but not limited to, the following are additional expenses paid by the participant: transportation to/from the retreat location, any food or drink costs outside of the listed meals and provided beverages, gratuities, travel insurance, private yoga lessons, and optional massage sessions.

Travel Arrangements & Insurance:

Travel insurance is HIGHLY recommended in case of unexpected sickness, losses, or other last-minute emergencies. Most travel insurance plans will reimburse you for the cost of the retreat, your airfare, and other non-refundable expenses, including those related to Covid-19 such as trip cancellation, trip delay, or quarantine. Purchase of travel insurance is your responsibility and at your own cost. 502 Power Yoga shall not be held liable for any consequences arising from delays or cancellations in any of the companies you may have made arrangements with.

We also strongly encourage participants to ensure they are covered by medical insurance should any medical issues arise. **Your safety is ultimately your responsibility.** All risks associated with not being covered by appropriate insurance are assumed by the participant.

Personal Property:

By signing, you acknowledge and agree that you are responsible for all personal property during the Retreat and that we are not responsible for lost, stolen, or damaged items.

Environmental Awareness:

Whilst all measures are taken to ensure a high standard of health and safety, we are situated in a location where the land is uneven at times and we shall not be responsible for any injuries caused by uneven terrain.

Physical Readiness:

By signing this contract, you confirm you are physically capable and prepared for the exertion levels required with hiking and a rigorous yoga practice. Hiking, yoga, and other activities are all optional, and done at your own risk.

Media Release:

I understand that during a Retreat, participants may be photographed or videotaped. I allow 502 Power Yoga, LLC to use such images, words, and likenesses for marketing, on websites, social media, in brochures or other writings, and for any other legitimate purpose.
